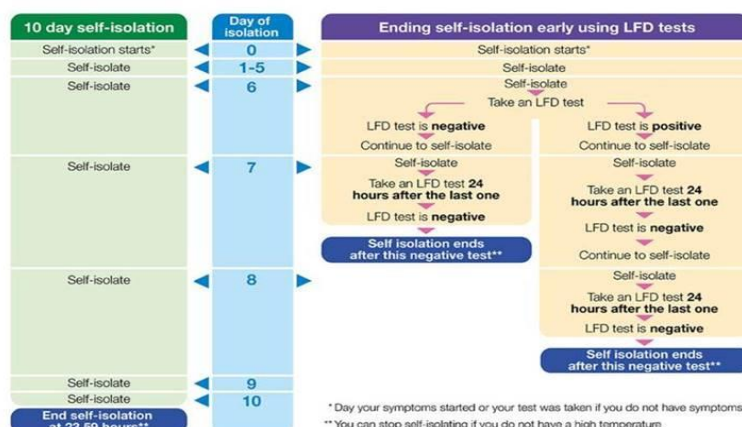
Latest Updated Guidance COVID-19

As you will be aware, the DFE has released updated guidance to schools regarding COVID-19 and I wanted to share some key information with you.

Although the DFE does not require primary schools to Track and Trace, as a school, we have decided to continue to do so, to ensure we are doing everything possible to reduce the COVID-19 transition rate in our community. We will therefore notify you by email if your child is in a class that has a positive case whilst in school. The requirement would then be for your child to carry out LFD tests daily for 7 days and continue to attend school and to contact us as soon as possible if the results are positive.

Individuals who have had a positive COVID-19 case may now take LFD tests on day 6 and day 7 of their self-isolation period. Those who receive two negative test results are no longer required to complete 10 full days of self-isolation. The first test must be taken no earlier than day 6 of the self-isolation period and tests must be taken 24 hours apart. If both of these test results are negative, and they do not have a high temperature, your child may end their self-isolation after the second negative test result and return to school from day 7. I have attached a chart below for information.

Examples of when to end self-isolation if you have had COVID-19 symptoms or have received a positive COVID-19 test result

Please continue to report any positive COVID-19 results by sending a picture of your child's lateral flow test to the school email, as well as reporting to the NHS <https://www.gov.uk/report-covid19-result> along with their expected return date.

Where family members test positive for COVID-19, as long as your child tests negative on LFD tests and shows no symptoms, they should continue to attend school.

Can I take this opportunity to thank you for your continued support in this unprecedented time. We fully appreciated the added pressure the current climate has in terms of attendance to school.
