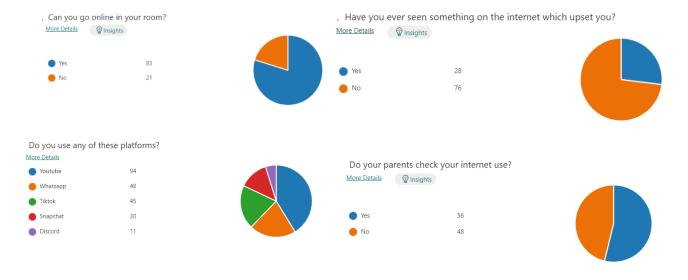

Online Safety Questionnaire

Dear Parents/Guardian,

From a young age, children have access to the online world including using social media. At Bearwood, we believe it is extremely important children not only learn to use technology as a tool but also know how they can keep safe. As a result, we have asked the children from Years 2 onwards to complete an online safety questionnaire to give them the opportunity to reflect on their own use of the internet and promote discussion. The questionnaire completed by the children will be used as a tool to identify how we can best support children to stay safe online and also allow both the school and parents/carers to have an insight into the children's own perception of online safety and current uses of social media. The data will act as a baseline allowing us to see the progression throughout the school years. Please find the results below as well as a summary of the findings:

Summary:

- An increasing number of children either have their own phone or device which they
 can access the internet from. Even from Year 2, over half the class have access to a
 device connected to the internet.
- A high percentage of each year group has access to the internet from within their own rooms and on average, over half the pupils who responded on the survey said their parents did not check their internet use.
- On average, over one third of the children responded saying they speak to people that they do not know. This may include online gaming or on social media.
- Around one fifth of responses indicate children have at some point received a nasty message online or by text and one third have seen something via the internet that they found upsetting; Year 2 responded with over half seeing something upsetting.
- Many children use social media such as TikTok and Snapchat despite it having a 13+ age rating. The age ratings are based on the data rules and policies that the companies need to comply with. Companies are prohibited from collecting and storing data for under 13s unless they have permission from parents/carers.

As new devices are produced and new online content is created, it is important we continue to stay aware of how we can best support the children in being safe online. Below are some useful links including setting up parental controls and understanding age guides. Useful links:
